It is alleged that Shahriar Kabir, through his talk show on TV channel 71, indirectly instigated the police force to shoot indiscriminately towards the students. Said Lisa Akhtar died on 22.07.2024. The first information report alleged that Shahryar Kovid is a groveller and broker of the previous government and an Islamophobic intellectual. It is further alleged that to resist the all-out peaceful movement, under the direct and indirect instructions of Sheikh Hasina, he made provocative statements through 71 TV and termed this logical demand of the students as illogical through talk shows of 71 television channel.	19.12.2024
